# FACT FINDING MISSION TO CAMPANIA (ITALY) 27 -30 APRIL, 2010

# OUTLINE PROGRAMME as at 18.03.2010

<u>The objectives</u> of the visit are to investigate the allegations contained in the petitions received, and previously discussed in Committee both during the previous legislature and most recently in December 2009 and January 2010, which refer to the environmental and health consequences of the waste crisis in Campania. (Petitions 683-05 (landfill: site visit), 31-06, 26-07 (landfill: site visit), 587-07, 756-07, 789-07, 910-07, 991-07, 12-08, 16-08, 209-08, 347-08 (incinerator: site visit), 955-08 (landfill: site visit), 1011/08, 1082/08)

Members of the delegation will meet with the petitioners and with local communities which are the most directly affected by this situation, with those companies which are administering the various waste facilities visited, and with the responsible local, regional and national authorities. To get an independent view the opinion of scientific researchers will be sought (geologist, epidemiologist, sociologist). Meetings will therefore take place in Naples and with some of the local communities most affected notably where petitioners have brought the situation to the attention of the Committee.

The following issues have so far been identified for particular attention:

General application of the Waste Framework Directive and the Landfill Directive, as well as potentially the IPPC Directive; status of existing landfills, dioxins, seepage, illegal waste on land and sea, toxic waste issues, recycling of waste, health impact of waste deposits in locally affected communities, incineration, including the cost of incinerator and conformity with public procurement rules
